- a. Cohort growth over time via MAP/Cohort match data
 - We viewed data from MAP as it compares to Winter 2019 and Winter 2020
 - School is on a good trajectory
 - Board comment: Are there elements of virtual that are beneficial. What about distance learning do we keep as there are things that are working for some of our learners
 - Board comment: Survey our learners as there is something about the distance learning format that is allowing them to be more successful
 - Board comment: Could we move to some days in-person and some days virtually
 - Board comment: Is it because we only serve two days a week so they focus on high leverage things
 - Board comment: 10% of learners are performing worse than ever and are disengaged with school
- b. For MAP, demographic breakdown on performance and how many took the test

- c. Leadership support and connection
 - Encourage learners to get out and move through using apps
 - Provide some way for kids to connect by grade level
 - Purpose behind the connection, make it meaningful
 - Leverage the things online that kids are drawn to and use as a vehicle to draw them in
 - ACLC Leaderboards potential
 - Tik Tok theme song for ACLC and have kids mimic on Tik Tok
 - Making learners aware of where to find forms for proposals. Resend to entire school and promote it.
- d. Attendance & grade correlation
 - There is a correlation between attendance and academic performance

- The more learners attend class the better their grades are
- Learners who attend camp two days a week are now attending more days per week because they are in the routine of going to school
- Camp success learners are seeing a 1point gain
